Some Members are exceptionally excluded from paying 28 days rent in advance. If you did not pay 28 days rent in advance, we will bill you for the remainder of the month you arrived at the College plus the full rent for the month ahead.
 Members are billed for the first time on the 1st of the month after arrival.
 Bills are emailed on the 1st of each month and must be paid by the 10th of the month. The amounts in the table above show the accommodation fees only - you may have other charges for things you have ordered (campbeds, Royal Albert Hall tickets, sublets, electricity charges for flats and studios etc).
 Those in studios and flats only will also pay a separate electricity charge which you can see on our website.
